



IMGRAD CR 45 clean room »walls and coverings« system is designed in a modular way with 45 mm thickness. Prefabricated clean walls and panel linings are designed to be easily dismantled and moved to a new or back to the old location.






# MODULAR WALK-ON CLEAN CEILING







All corner contact points between the panels are joined together by ALU cove-shaped profiles. On floors and corners, such contact points enable more precise and easier cleaning of the surfaces.

IMGRAD CR walk-on clean ceiling panel system is designed in a modular way with 52 mm thickness.
Modular clean ceiling IMGRAD CR is made of diverse flat materials: aluminium sheet metal, galvanized sheet metal, bactericidal sheet, inox sheet metal.

# **GLAZING PANELS**





Non walk-on ceiling is composed of aluminium, galvanized or inox panels. Non walk-on ceiling system is a very flexible solution as it allows for dismantling of each panel separately in a very short time period. The modular **IMGRAD CR** 45 double glazed panel is systematically compatible with the wall panels.

The glazed panel is 45mm thick and can be disassembled.

The panel frame is made of aluminium airtight profile with absorbent

## **SLIDING DOOR**





IMGRAD CR airtight clean room door are made of anodized profiles.

The door edges are smooth and rounded. The door thickness is 45mm. The basic construction is made of aluminium profiles and rock wool is used as a filling material.

IMGRAD CR sliding door are made of anodized profiles. The door edges are smooth and rounded.

The door thickness is 45mm. The basic construction is made of aluminium profiles and rock wool is used as a filling material.


The joints are sealed with a durable high quality one-component polyurethane elastomeric sealant.



## CLEAN ROOM FLOOR



ACTIVE OR PASSIVE PASS-THROUGH BOX (PASSBOX)





IMGRAD CR modular clean room system allows for PVC or epoxy flooring implementation. The door, corner and wall rounded profiles enable a rounded floor finishing and easy cleaning.

IMGRAD CR pass-through box system is made by the same principle as all the other panel finishing details. With regard to the purpose of its use, the inside can be made of stainless sheet metal with special lamps, perforated shelves and ventilation.

As a rule, material barriers are assembled at the facility, however, upon request, they are entirely manufactured in IMGRAD production.


